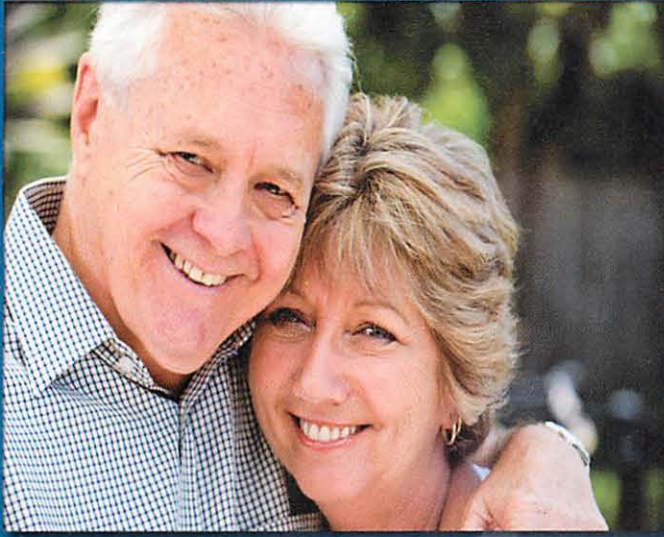

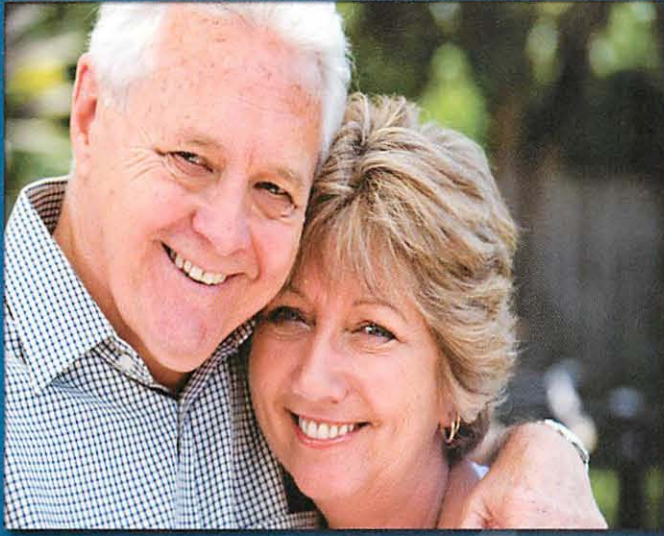

The YELLOW DOT Program is a cooperative effort between law enforcement, fire and rescue, senior groups, and emergency and medical services to aid in communicating important health information about you in case you may be unable to due to an automobile crash. Many people suffer from common health issues that emergency responders should be aware of for your proper care and treatment. The program is open to people of all ages and is easy to enroll in.

How does YELLOW DOT work?

The process is simple. Come in to one of the WVDMV Regional Offices and explain that you would like to participate in the YELLOW DOT program. You will be given a program consent form to sign. When you return the completed consent form you will be given the YELLOW DOT packet, which contains a Participant Information form you will need to complete on your own. A photograph will be taken of you and affixed to your Participant Information form and you will be provided with a YELLOW DOT folder and decal. After you complete the information form, place it in the YELLOW DOT folder, which will go in the glove compartment, so emergency response crews know where to find it. A YELLOW DOT sticker is then placed on the rear window on the lower left corner. This will tell the first responders that vital information is in the glove compartment.

Are You Prepared?

Do you have a treatment plan in place
in the event of an automobile crash?

Beginning April 10, 2012, the Yellow Dot Program (YDP) will be kicked- off and will be available to West Virginia citizens throughout the State.

The YDP is mainly geared toward the senior population who has a medical condition or suffers from allergic reactions to certain medications; however, anyone of any age can participate.

Interested participants may sign up to participate in the program at any DMV Regional Office throughout the State beginning April 10, 2012. The participant will be asked to sign a consent form, they will then be provided with a current picture, an emergency contact/medical information sheet and a Yellow Dot folder to house these items in the glove compartment. A Yellow Dot Sticker will also be provided to be placed on the outside of the lower left rear window of the vehicle.

In the event of a crash, the first responder will know to look for a yellow dot sticker on the rear window and look in the glove compartment for a yellow dot folder containing information about the driver, a list of medications taken, allergies, etc., along with a photograph of the individual.
