On behalf of the Calhoun County Board of Education, we are releasing the financials for Calhoun County Schools fiscal year 19, ending June 30, 2019. We are pleased to announce a significant reduction in the deficit. As you know, the deficit was at an all-time high of 1.8 million several years ago. The teachers, service personnel and administrators took a significant pay reduction at that time. The students, teachers, administrators, and board have worked continuously to reduce the deficit over the last few years. This has reduced the deficit to \$737,891. This significant reduction is due to the diligent work of the teachers, service personnel, administrators and the board. We still have work to do to get completely out of the deficit, but we are heading in the right direction. We continue to look every day to see how we can save money. I personally want to thank the students, parents, community, teachers, service personnel, administrators and board members for making the sacrifices needed to reduce the deficit.
