- All parade participants shall arrive at the Grantsville Volunteer Fire Department no later than 5:00 pm in order to allow parade staff time to coordinate and lineup and start the parade on time. Parade participants will be notified of additional parade-day details or changes as the date draws nearer so please be sure to include an email address on your application.
- All applications are reviewed by the Parade Committee in order to ensure that they are appropriate for a family-oriented parade. You will be notified by the Parade Committee should your request to participate be declined.
- By signing below, you shall commit your group, organization, self to participate in the parade and we will be anticipating your attendance. If, for any reason, you are unable to participate after submission of this application, please notify organizers as soon as possible at 304-354-7017 or 304-553-6105.

Safety Guidelines: 1. Drivers of floats must be at least 18 years of age, have a license for the vehicle being operated, and must have liability insurance. 2. CANDY will be allowed to be thrown from floats/vehicles, please wear gloves. 3. Small children **MUST** be chaperoned/accompanied by an adult when riding on top of vehicles. 4. It is strongly recommended that you wear proper safety equipment if you are riding a motorcycle, wheelchair, go-kart, bicycle, or horseback. If you choose not to wear safety equipment you do so at your own risk.
